## Part 1 Scope and application

- (1.1) All Players registered to play cricket in any competition owned, operated and/or managed under the auspices of CNSW or its Affiliates are bound by and comply with all rules, regulations, constitutions and by-laws, codes of conduct, and policies of CNSW.
- (1.2) Players acknowledge that it is their personal responsibility to familiarise themselves with all of the requirements of the Code of Conduct, including what behaviour constitutes an offence under the Code of Conduct; including what behaviour, action or inaction constitutes an offence as set out in this document.
- (1.3) Players agree to submit to the exclusive jurisdiction of the CNSW Code of Conduct Commissioner, Judiciary Committee or other Hearing Tribunal convened under the Code of Conduct to hear and determine charges brought pursuant to the Code of Conduct.

## Part 2 Spirit of Cricket

(2.1) The Preamble to the Laws of Cricket sets out the Spirit of Cricket as follows:



#### The Spirit of Cricket

Cricket owes much of its appeal and enjoyment to the fact that it should be played not only according to the Laws, but also within the Spirit of Cricket.

The major responsibility for ensuring fair play rests with the captains, but extends to all players, Match Officials and, especially in junior cricket, teachers, coaches and parents.

Respect is central to the Spirit of Cricket.

Respect your captain, team-mates, opponents and the authority of the umpires. Play hard and play fair. Accept the umpire's decision.

Create a positive atmosphere by your own conduct, and encourage others to do likewise. Show self-discipline, even when things go against you.

Congratulate the opposition on their successes, and enjoy those of your own team. Thank the officials and your opposition at the end of the match, whatever the result.

Cricket is an exciting game that encourages leadership, friendship and teamwork, which brings together people from different nationalities, cultures and religions, especially when played within the Spirit of Cricket.

### Part 3 Code of Conduct Offences

- (3.1) The conduct described in Schedule A, Articles A.1 to A.21 will amount to an Offence under the Code of Conduct if committed by a person who is bound in accordance with the Cricket NSW By-Laws and/or who has otherwise agreed to be bound by the Code of Conduct.
- (3.2) Guidance notes have been provided in the text boxes beneath the description of a particular offence. Such notes are intended only to provide guidance as to the nature and examples of certain conduct that might be prohibited by a particular Article and should not be read as an exhaustive or limiting list of conduct prohibited by such Article.
- (3.3) For the purposes of the Code of Conduct, the phrase "during a Match" should be interpreted broadly to cover all conduct which takes place at the ground on the day of a Match, and not just conduct which takes place on the field of play. It will therefore include conduct which takes place off the field of play at the ground on the day of the Match, for example in the changing rooms, or during any of the intervals in the Match and will be deemed to have occurred "On Field" for the purposes of this Code of Conduct.
- (3.4) For the avoidance of doubt, in circumstances where a Person Reported is involved in an off-field incident which may warrant action under the CNSW Integrity Framework, the Commissioner will liaise with the CNSW Head of Integrity to determine what the most appropriate course of action against the Person Reported should be.



# Part 4 Reporting

(4.1) Any one of the following individuals can report an alleged offence under the Code of Conduct by lodging a report in the manner described in clause 5.2, below (a Report):

- (a) An Umpire;
- (b) An Executive Officer or appointed official of either of the two Cricket Organisations whose representative teams participated in the Match during or in relation to which the alleged offence was committed;
- (c) CNSW Chief Executive Officer (or his or her designee);
- (d) An Executive Officer or appointed official who is from or affiliated with the Cricket Association to which the relevant Reported Person belongs.
- (4.2) All Reports must be completed on the CNSW Reporting Form as made available for this purpose by CNSW from time to time. All Reports must be signed and dated by the Person Reporting.
- (4.3) A Report may be withdrawn at any time before a hearing by the Person Reporting.

### Part 5 Initial review and Notification procedure

(5.1) The following will apply to the lodgement of all Reports:

- (5.2) All Reports will go through an initial review by the Commissioner who will determine whether the Reported Person named in the Report has a case to answer in relation to the matters identified in the report and, if so, determine the type and/or level of offence is. Combine with 5.5
- (5.3) Commissioner may, in their absolute discretion, seek further evidence as part of the initial review including notifying the Person Reported.
- (5.4) If the Commissioner believes that there is no case to answer, they will notify the Competition Administrator and/or Head of Integrity as appropriate who will inform the Person Reporting of the decision and the reasons that such a determination has been made and that no action is to be taken against the Person Reported.

#### Notice of Charge

- (5.5) After the initial review is complete, the Commissioner will issue a Notice of Charge that will specify the Reported Person has the following options:
  - (a) they may admit the offence charged and accept the proposed sanctions specified in the Notice of Charge, provided that the admission is received by the Commissioner or the Head of Integrity (as the case may be) prior to the time specified for the hearing; or
  - (b) they may admit the offence charged and dispute the proposed sanction specified in the Notice of Charge, in which case the matter will proceed to a hearing in accordance with Part 6; or
  - (c) they may deny the offence charged, in which case the matter will proceed to a hearing in accordance with Part 6.
- (5.6) Non-compliance of the Person Reported to respond to the Notice of Charge will not prevent the relevant decision-maker from proceeding with the hearing in their absence, provided that the decision-maker has made reasonable enquiries as to why there has been no response.

#### Part 6 Disciplinary procedure

- (6.1) A Reported Person cannot attempt to negotiate, bargain or otherwise seek to reduce the imposed sanction in relation to any alleged offence committed under this Code of Conduct.
- (6.2) Any Commissioner or Judiciary Committee will conduct any disciplinary procedure under these Code of Conduct Procedures with as little formality and technicality and as quicky as possible, subject to proper consideration of the Report being permitted.
- (6.3) For any Level 1 Offence and Level 2 Offence that proceeds to a hearing, the case will be heard by the Commissioner.
- (6.4) The Commissioner may determine the procedure at the hearing in their absolute discretion, subject to ensuring that the Reported Person is provided a fair and reasonable opportunity to present their case.
- (6.5) For any Level 3 Offence and Level 4 Offence or a Level 2 offence under A.12, A.15 and A.21 that proceeds to a hearing, the case will be heard by the CNSW Judiciary Committee.
- (6.6) The Judiciary Committee may determine the procedure at the hearing in their absolute discretion, subject to ensuring that the Reported Person is provided a fair and reasonable opportunity to present their case.



## Part 7 Standard of Proof and evidence

- (7.1) Unless otherwise described herein, the standard of proof in all cases brought under the CNSW Code of Conduct is whether the Commissioner and/or the Judiciary Committee is comfortably satisfied, bearing in mind the seriousness of the allegation that is made, that the alleged offence has been committed.
- (7.2) The Commissioner and/or the Judiciary Committee will not be bound by the rules of evidence. Instead, facts relating to an offence allegedly committed under the Code of Conduct may be established by any reliable means, including admissions.
- (7.3) The Commissioner and/or the Judiciary Committee may draw an adverse inference against the Reported Person based on their refusal, without extenuating circumstances, to appear at the hearing and/or to answer any relevant questions.

### Part 8 Sanctions on Reported Persons

- (8.1) Where a Commissioner or Judiciary Committee determines that an offence under the Code of Conduct has been committed, they must impose a sanction on the Reported Person.
- (8.2) Sanctions will be imposed using the prescribed penalties set out at Schedule B.
- (8.3) In determining the sanction, the Commissioner must first consider whether the Reported Person has previously been found guilty of any offences at the same Level (but not necessarily under the same Article) of the Code of Conduct (or any predecessor regulations that may have applied) within a period of three years prior to the date on which the proven offence took place.
- (8.4) Other than the consideration at clause 8.3, the Commissioner or Judiciary may take into account any other factors that they deem relevant and appropriate to the mitigation or aggravation of the nature of the Offence before determining, in accordance with Schedule B, the appropriate sanction(s). Those factors may include:
  - (a) The seriousness of the breach;
  - (b) The harm caused by the breach to the interests of cricket;
  - (c) The Person Reported's seniority and standing in the game;
  - (d) Any remorse shown by the Reported Person and the prospect of further breaches;
  - (e) The prior record of the Reported Person in abiding by this Code of Conduct.
- (8.5) For the purpose of determining suspension periods for a Reported Person, the interpretative provisions regarding Suspended Players as set out in the CNSW By-laws will apply.
- (8.6) During any period of suspension, the Reported Person must not play, coach or otherwise participate or be involved in any capacity in any Matches which take place during the suspension period.

**Note:** For the avoidance of any doubt, the Reported Person must not be nominated as, or carry out any of the duties or responsibilities of, a substitute fielder; or enter any part of the playing area (which includes the field of play and the area between the boundary and perimeter boards) at any time, including during any scheduled or unscheduled breaks in play.

(8.7) For the avoidance of doubt:



- (a) the Commissioner or any Judiciary Committee has no jurisdiction to adjust, reverse or amend the results of any Match;
- (b) where a Reported Person is found guilty of committing two separate Code of Conduct offences that do not relate to the same incident or set of circumstances arising during a Match and is sanctioned separately for each offence, then any sanctions should run cumulatively (and not concurrently);
- (c) where a Reported Person is found guilty of committing two Code of Conduct offences in relation to the same incident or set of circumstances arising during a Match and sanctioned separately, then any sanctions imposed should run concurrently (and not cumulatively);
- (d) where the Commissioner or a Judiciary Committee finds a Reported Person not guilty of the offence allegedly committed under the Code of Conduct, it remains open to them, in their absolute discretion, to find the Reported Person guilty of an offence of a lower level than that with which they have been charged.

## Part 9 Appeals

#### General matters relating to appeals

- (9.1) Subject to clause 9.4, an appeal can be lodged by:
  - (a) The Person Reported; or
  - (b) The Person Reporting; or
  - (c) In the case of decision of Level 2 offence under A.12, A.15 and A.21 ("Off-Field" only) Offences, a Level 3 Offence or a Level 4 Offence, the CNSW Chief Executive Officer.
- (9.2) There is no right of appeal against:
  - (a) any Commissioner decision to take no action under clause 6.4(b)(i) of the CNSW By-laws;
  - (b) any Commissioner decision to refer a matter to a Judiciary Committee or the Head of Integrity for determination of procedure, or for hearing; or
  - (c) the decision of a Person Reported to admit the offence charged and accept the proposed sanction.
- (9.3) The following will apply to all Appeals:

\*Note: For the avoidance of doubt, the right of appeal will be determined by reference to the level of offence which the decision of the Commissioner or the Judiciary Committee (as applicable) relates to, and not the level of offence originally reported. In circumstances where the application of clause 9.4 would



lead to the same level of adjudicator hearing the appeal as heard the first instance case, then the relevant adjudicatory body will be the higher body.

- (9.4) For all appeals lodged, the original decision remains in effect throughout the duration of the appeal process until a decision is made by the relevant appeals decision-maker.
- (9.5) All appeals against a first time Level 1 Offence will be heard on the papers and the sole ground of appeal will be a failure of the Commissioner to follow the procedures in this document and that such failure has caused a denial of procedural fairness to occur.
- (9.6) All appeals from decisions in relation to a second or subsequent Level 1 Offence or a Level 2 Offence (except as provided by clause 9.4) will be held as a hearing de novo (i.e. they will hear the matter over again, from the beginning), without being bound in any way by the decision being appealed.
- (9.7) All appeals from decisions of a Level 3 Offence or Level 4 Offence or Off-Field Offences:
  - (a) will be referred to the National Sports Tribunal, unless the circumstances require that the matter be referred to the CNSW Appeals Tribunal; and
  - (b) where required in order to do justice (for example to cure procedural errors at the first instance hearing), the appeal will take the form of a hearing de novo (i.e. they will hear the matter over again, from the beginning), without being bound in any way by the decision being appealed. In all other cases, the appeal will not take the form of a de novo hearing but instead will be limited to a consideration of whether the decision being appealed was erroneous; and
  - (c) if the matter is heard by the CNSW Appeals Tribunal, that Tribunal will have the power to order some or all of the costs of the appeal proceedings (including the costs of holding the hearing, the legal and/or travel/accommodation costs of the Commissioner and/or any other relevant parties,) to be paid by the appealing party if he/she considers that such party has acted spuriously, frivolously, without reasonable cause or otherwise in bad faith.
- (9.8) There will be no further appeal rights available.

## Part 10 Definitions and Interpretation

#### **Defined Terms**

(10.1) Defined terms not otherwise defined in this Policy have been defined in, and have the meaning given to them in, the CNSW By-Laws. In this Policy, the following words have the corresponding meaning:

Umpire	means a person who officiated in the Match during or in relation to which the alleged offence was committed, whether or not they are an accredited umpire with the New South Wales Cricket Umpires and Scorers Association.

#### Interpretation

(10.2) In this Policy:

- (a) references to 'including' or similar words are not words of limitation;
- (b) 'business day' means a day other than a Saturday, a Sunday or a day which is lawfully observed as a public holiday in the State of New South Wales;
- (c) all notices must be in writing and in English;
- (d) words in the singular include the plural and vice-versa;
- (e) a construction that would promote the purpose or object underlying this Policy must be preferred to a construction that would not promote that purpose or object; and
- (f) to the extent that there is any inconsistency between a term of any legislation and a term of this Policy, the term of that legislation overrides the Policy and applies to the extent of the inconsistency.



# Part II Schedule A – Offences

(11.1) The table below prescribes the conduct that will amount to an Offence under the Code of Conduct if committed by a person who is bound in accordance with the Cricket NSW By-Laws and/or who has otherwise agreed to be bound by the Code of Conduct.

Without limitation, Article A.1 includes:</li> <li>(a) excessive celebration directed at and in close proximity to the dismissed batter; (b) verbally abusing the dismissed batter; or (c) pointing or gesturing towards the pavilion.</li> </ul>

A.2	Excessive appealing during a Match	
Note:	For the purposes of Article A.2, 'excessive' may include: (a) repeated appealing of the same decision/appeal; (b) repeated appealing of different decisions/appeals when the bowler/fielder knows the batter is not out with the intention of placing the Umpire under pressure; (c) charging or advancing towards the Umpire in an aggressive manner when appealing; or (d) celebrating or assuming a dismissal before the decision has been given. It is not intended to prevent loud or enthusiastic appealing.

A.3	Use of an audible obscenity during a Match
Note:	Article A.3 covers the use of words commonly known and understood to be offensive, obscene and/or profane (in any language) which can be heard by spectators and/or the viewing public whether by way of the stump microphone or otherwise. This conduct may include, for example, swearing in frustration at one's own play or misfortune.
	This offence is not intended to cover any conduct that is likely to offend, insult, humiliate, intimidate, threaten, disparage or vilify any reasonable person in the position of a Player or Player Support Personnel or any other person (including spectator) on the basis of that person's race, religion, culture, descent, colour, national or ethnic origin, sex, gender, sexual orientation, disability, marital status and/or parental status. Such conduct is captured by the CNSW Integrity Policies.

A.4	Disobeying an Umpire or Match Referee's instruction during a Match
Note:	Article A.4 includes any repeated failure to comply with the instruction or directive of an Umpire or Match Referee during a Match.

A.5	Abuse of cricket equipment or clothing, ground equipment or fixtures and fittings during a Match
Note:	Article A.5 includes any action(s) outside the course of normal cricket actions, such as hitting or kicking the wickets or any deliberate (ie intentional), reckless or negligent (in either case even if accidental) action(s) to fixtures or fittings including but not limited to the advertising boards, boundary fences, dressing room doors, mirrors, windows and other fixtures and fittings.
	For the avoidance of doubt, the wickets or any other fixtures or fittings do not need to be damaged in order to constitute a breach of Article A.5.
	For example, this offence may be committed, without limitation, when a Player swings their bat vigorously in frustration and hits a structure at the ground.
